### TO WHOM IT MAY CONCERN

We write on behalf of Intercapre Ferreira Bus Services (Pty) Ltd regarding the illegal transportation of passengers by Road Link Passenger Services (Pty) Ltd between Cape Town and Pretoria via Upington.

The position is that the permits (operating licences) that were issued to Road Link by the Operating Licencing Board Western Cape, for the transportation of passengers between Cape Town and Pretoria via Upington in terms of application OP668821 were suspended by the Transport Appeal Tribunal in terms of section 13(b) of the Transport Appeal Tribunal Act, 39 of 1998 on 7 July 2008. As soon as the permits were suspended, the transportation of the aforementioned passengers by Road Link became unlawful.

Road Link endeavoured to legalise their operation by approaching the High Court, Transvaal Provincial Division under case number 36008/08 to have the decision of the Transport Appeal Tribunal to suspend the licences set aside. It is to be noted that the bringing of the said application didn't legalise the Road Link operation and that it remained illegal throughout.

The forementioned application by Road Link was dismissed with costs by the Court on 17 November 2008 and the Court inter alia, obiter ruled that the Transport Appeal Tribunal acted within their rights to suspend the permits. See annexure "A".

In a further endeavour to legalise the operation, Road Link applied for leave to appeal against the forementioned decision. It is again to be noted that the bringing of the said application for leave to appeal also did not legalise the operation of Road Link, and the said application was in any event dismissed by the Court on 8 December 2008. See annexure "B".

The effect of the forementioned is that the Road Link's operation over the Cape Town / Upington / Pretoria route remains illegal and is rendered in total disregard of the law.


